# Scope

This policy applies to any ANVC member that is interested in announcing research studies to the ANVC membership and soliciting their involvement in the completion of the study.

# **Policy**

All applicants must be members of the ANVC. Applications must be submitted to the ANVC via <a href="mailto:info@anvc.org">info@anvc.org</a>. All applications will be reviewed the ANVC Board of Directors. A majority verdict is required for approval.

#### All applications must contain the following information:

- Project title and abstract (max 250 words)
- Study significance and innovation
- Research strategy:
  - Hypotheses or research question(s)
  - Design and study methods (target sample with inclusions/exclusions; setting; enrollment procedures; study protocol; statistical analysis plan; limitations to approach and alternatives; subject risks/benefits; study completion timeline)
- References
- Institutional Review Board (IRB), Human Research Ethics Committees (HREC) (or appropriate) ethics approval letter
  - This MUST be obtained prior to submission. Any submissions lacking IRB approval will be automatically rejected.
- Payment details.

#### Endorsement inclusions and cost

Successful research studies will be provided with the following promotions through the ANVC:

- One (1) email blast to the ANVC membership with a link to the research materials
   Disclaimer: The ANVC does not give out email addresses. The message will be sent by the ANVC Executive Office to the membership from the applicant's email.
- A total of four (4) social media and/or Connect newsletter announcements
   Disclaimer: The ANVC Executive Office will post the social media and ANVC newsletter announcements.

Total cost: \$2000 USD

- Notice of approval will be provided in writing and payment deducted/invoiced.
